

## Admission Rules:

Foreigners and persons without citizenship permanently residing in Ukraine, persons with refugee status in Ukraine, persons requiring additional or temporary protection, and persons who have been granted a status of a foreign Ukrainian and who are legally in Ukraine, have the right to obtain higher education on a par with the citizens of Ukraine. These categories can be provided with state-subsidized higher education within the limits set by the Cabinet of Ministers of Ukraine.

### **The admission details for foreigners and persons without citizenship**

1. The admission of foreigners and persons without citizenship to the PSACEA is carried out in accordance with the Laws of Ukraine "On Higher Education", "On the Legal Status of foreigners and persons without citizenship", "On foreign Ukrainians", "On Refugees and Persons Who Need an Additional or temporary protection ", by the Decree of the President of Ukraine, June 03, 1994, No. 201" On Measures for the Development of Economic Cooperation of the Ukrainian Regions with the Contiguous Regions of the Republic of Belarus and the Administrative-Territorial Units of the Republic of Moldova ", the Decrees of the Cabinet of Ministers of Ukraine , 26 February 1993 No136 "On the training of foreign citizens in Ukraine", September 11, 2013, No. 684 "Some questions for recruiting foreigners and persons without citizenship", by the order of the Ministry of Education and Science of Ukraine dated November 1, 2013 №1541 "Some issues of the organization of recruitment and training (internship) of foreigners and persons without citizenship" by the Ministry of Justice of Ukraine on November 25, 2013 under No. 2004/24536.
2. Foreigners and persons without citizenship (hereinafter referred to as foreigners) may obtain higher education at PSACEA for the benefit of individuals and/or legal entities unless otherwise provided by international agreements of Ukraine, the consent to be bound by the Verkhovna Rada of Ukraine, laws or agreements on the International Mobility between PSACEA. Admission of foreigners to state-subsidized higher education institutions is provided according to quotas for foreigners.
3. Foreigners who arrive in Ukraine for the purpose of studying, enter PSACEA under accredited educational programs (specialities). Admission of foreign students to study at the expense of individuals and/or legal entities

may be carried out by PSACEA: 1) Once a year from June 15, 2019 to October 30, 2019 to obtain a Bachelor's degree, a Master's degree; 2) during the academic year for post graduate and doctoral studies.

PSACEA calculates the applicant's scores/assessments based on the document about the previous education and sets the minimum score in general subjects to conduct entrance examination.

Admission of foreigners to study at the appropriate level of higher education is based on the results of entrance examinations in specified subjects and language of instruction and on the basis of the academic regulations of continuing education, provided by the document on the acquired level of education in the country of its origin, and taking into account the marks/assessments that give the right to continue education at the next level of higher education in accordance with the legislation of the country that issued the document on the acquired degree (level) of education.

4. All categories of foreigners enrolled are credited to PSACEA of Ukraine on the basis of enrollment orders that are formed in the Unified Base.
5. The requirements of PSACEA regarding the correspondence of the foreign applicants who arrived in Ukraine to study, the conditions for admission to the corresponding levels of higher education, as well as the terms for accepting applications and documents, conducting entrance examinations, creative competitions and enrollment are specified in the Rules of admission to PSACEA and published on the official website of PSACEA ([www.pgasa.dp.ua](http://www.pgasa.dp.ua)).
6. Foreigners who have undertaken foundation programme in PSACEA (with the relevant document) are enrolled to PSACEA without an interview, except for the speciality 191 "Architecture and Urban Planning". For admission to specialty 191 "Architecture and Urban Development" a creativity competition (entrance test) is conducted in drawing and composition.

Entrance exams (interviews) for admission to the Bachelor's degree, Master's degree are held from June 15, 2019 until October 28, 2019.

Upon admission to a Bachelor's degree, on the basis of complete secondary education, entrance examinations are conducted by relevant (attestation) commissions of PSACEA in the following general subjects (creativity competitions): the Ukrainian language (Russian language), Mathematics, Drawing and Composition.

7. Foreigners and persons without citizenship submit the following documents to enter PSACEA:
  - a. application form;

- b. translation of the first page of the passport (surname, name) in the Ukrainian language, legalized in the manner prescribed by the state authorities of Ukraine, unless otherwise provided by international treaties of Ukraine;
  - c. the original of the document of secondary education and an extract of the obtained marks (scores) translated into the Ukrainian language and legalized in the order established by the state authorities of Ukraine, unless otherwise provided by international agreements of Ukraine;
  - d. a copy of the birth certificate translated into Ukrainian and legalized in the manner prescribed by the state authorities of Ukraine, unless otherwise provided by international treaties of Ukraine;
  - e. the original of the health certificate verified by the health authority of the applicant's country and issued not earlier than two months before the entry into Ukraine, translated into Ukrainian and legalized in the manner prescribed by the state authorities of Ukraine, unless otherwise provided by international treaties of Ukraine;
  - f. Emergency medical insurance policy;
  - g. 10 photos in size 3,5x4,5 cm, coloured, matte;
  - h. a copy of the certificate of a foreign Ukrainian (if any);
  - i. a return ticket with an open date of departure for one year period to return home;
  - j. passport with visa appropriately issued for entry into Ukraine (presented personally);
  - k. Official Invitation to PSACEA.
8. Foreigners who receive state scholarships under international agreements, national programs, and other international commitments of Ukraine are enrolled to study within the established quotas for foreigners on the basis of the directions of the Ministry of Education and Science of Ukraine.
9. Foreigners who come to Ukraine for participation in academic mobility programs or for higher education in accordance with educational programs agreed between Ukrainian and foreign higher education institutions are enrolled for study, taking into account the respective contractual obligations of PSACEA.
10. Foreign Ukrainians who are legally in Ukraine and whose status is stated in a Document of foreign Ukrainian, when applying to PSACEA have the same rights to get education as the citizens of Ukraine, with the exceptions established by the Constitution of Ukraine, laws of Ukraine or international treaties, the consent of which is binding on the Verkhovna Rada of Ukraine.

11. Foreign Ukrainians, whose status is stated in a Document of foreign Ukrainian, may be enrolled for studying on state orders within the established quotas for foreigners for interviewing subjects envisaged by the Rules of admission of PSACEA.
12. Foreigners and persons without citizenship permanently residing in Ukraine, persons who have been granted refugee status in Ukraine, and persons requiring additional or temporary protection, and enter PSACEA according to the rules stipulated by the Conditions for admittance to the higher education institutions of Ukraine in 2019 for the citizens of Ukraine, may take part in the competitive selection to the places for government orders within the limits set by the Cabinet of Ministers of Ukraine on the basis of a special competitive score, which is calculated as the ratio of the applicant's competition score, determined in accordance with the clause 8 of section VII of these rules of admission, to the minimum competitive score for recommending places for the state (regional) order in the general competition for this competitive proposal in the previous year (in the absence of such score, a similar indicator is used for another, as closely as possible , a competitive proposal within the institution of higher education, in the case of impossibility - another institution of higher education by the decision of the admissions committee of PSACEA).
